To Whom it may Concern,

My name is [redacted] I am the mother of two wonderful children that two judges in the [redacted] municipal court have done a grave injustice to.

First of all, the judge presiding over me and my ex-husband's initial court hearing, refused to hear about his attempted suicide (in front of our children) or his tax fraud, simply because it occurred prior to our divorce being filed.

Judge [redacted] made a decision in [redacted] that has had a very bad impact on my children. Simply due to the fact that I had moved around, she found my ex-husband (who obviously has emotional problems) to be more fit as primary parent than me.

Since being appointed as primary parent of our children, my ex-husband has gone against many of the terms of the decree of the dissolution of our marriage, by allowing our children to be around his step brother [redacted] without his supervision. He also lied to our daughter's 2<sup>nd</sup> grade teacher, saying that he had sole custody and full rights to sign for her to fail 2<sup>nd</sup> grade, then didn't inform me until after school was out for summer. He also refuses to let me pick our children up after school until he gets off of work when our decree states that if one parent is unavailable the other parent is first choice.

I filed a request to change parenting time and primary parent. After a court hearing in which both my ex and his father blatantly lied, and consistently back tracked/proving their dishonesty, Judge [redacted] made a ruling stating that none of my accusations were grounded in fact and do not provide good cause for modifying parenting time.

Enclosed is my daughters first ~~and~~ 2nd Grade report card, (proving that she failed 2nd Grade) the only paper proof that I have, but Judge [ ] could have had a court mediator, or their Liason talk to my children to find out if the rest were true.

Instead she based her decision on the word of two men whose characters could be defined easily by their police records. My ex father in law, [ ] [ ] has had numerous police raids on his home and vehicle, my ex-husband [ ] has had numerous aggressive driving tickets as well as assault (which occurred in front of our children)

Since that ruling, my ex husband feels even more invincible when it comes to ignoring the ground rules of our divorce, He has picked up and dropped off our children late every Thursday this summer, one night he didn't have them home until almost midnight, and wouldn't answer his phone leaving me worried sick.

I have tried to get along with my ex-husband for my childrens sake, and we have come to agreements before, but just like the agreements in court, he goes against them as he pleases.

I am tired of trying to make my case in court, and do not have the financial resources to obtain representation to assist me. It is not fair that my children suffer because me and their father cannot get along, and they do suffer as long as he is allowed to do whatever he wants when it comes to them. I know that he loves our children very much, but he continually makes bad decisions that affect their well being. I'm not sure what if any assistance you can give me, but I do appreciate your time and consideration.
