JUDGE

HAS VIOLATED THE JUDICIAL CODE OF CONDUCT

The preamble states "Judges should maintain the dignity of the judicial office at ALL times and avoid impropriety and the appearance of impropriety in their professional and personal lives". They should aspire at all times to conduct that ensures the greatest possible public confidence in their independence, impartiality, integrity and competence".

Judge has in the past and present used **TAX PAYERS MONEY** to fight a personal civil case with her daughter (me) As reported in the Daily sun, Judge had Brad Bransky represent her in court for more than a year. At that time she was Chief Deputy Public defender; Bransky was her subordinate. He lied and stated he used personal time to represent Ms. however his vacation logs and personal time off showed he did not take time off from his job. In fact, he was seen going from the public defender's office to court for her case at all of the court appearances. He used the office to file address fax computer, all of the Public defender's equipment to prepare and present Judge case. PLEASE SEE ATTACHED DOCUMENTS TO SUPPORT THESE FACTS. THIS VIOLATES THE SUPERIOR COURT AND STATE A.R.S RULE AND LAW, PLUS CANNON 3, 3.1(E)

Along with this, others in the public defender's office acted as public notary and prepared other court documents once had to remove himself as attorney for Judge due to his illegal acts.

Jacque was interviewed and asked why she used tax payers' money to fight her case. She responded that she would have to sell her belongings to be able to afford a private attorney.

SHE LIED! In fact, Judge brought a brand new Toyota SUV, remolded her house and took a one month trip to Europe during the time that Bransky represented her in this case. THIS VIOLATES CANNON 1 RULE 1.2 A, AND COMMENT 1 AND 3!

After Bransky, Ms. obtained an attorney without selling any of her possessions. (See attached documents to support these facts.)

AFTER BEING LET OFF THE HOOK DUE TO HER STATUS AND FAMILY NAME AND WEALTH.

has and continues to break the law in effort to satisfy her obsession to put a daughter she did not raise in jail. THIS VIOLATES CANNON 2 RULE 2.4 B! From forging and altering court documents, lying in court, to stalking her daughter, (see enclosed) her personal activity is affecting her on the job.

Once again Judge recently used tax payers money FOR PERSONAL USE. She had police take the oldest son by force of the daughter she did not raise (due to Alcohol and substance abuse) not knowing what to do with the child she left the six year old unattended for hours in her Judge Chambers (please listen to audio tapes). The child admits later that the Judge stated she did not like the way Randy looked and was going to put him away for a long time. This accord several times during the month of July 2010. Please review the Judge's entry video cameras and courtroom THIS AGAIN VIOLATES CANNON RULE 3.1 E AND CANNON RULE 2.10-A (NOT TO MENTION WHAT IF ANY EVIDENCE LEFT IN THE CHAMBER WITH THE UNATTENDED CHILD WAS TAMPERED WITH.)

(Members of her family also witness this but due to their fear of Judge only interact with out of concern for the child). She also uses the division one court premises, equipment and other resources, to fight her civil case in California against her daughter. Where she is trying to have her daughter (me) put in jail. (See supporting documents) ONCE AGAIN VIOLATING CANNON 3.1 E. Along with having her Ca. attorney mention that Ms. was appointed Judge during the CA court proceeding, this changed the opinion and outcome of the CA case, where twice before the CA Solano county Judge Jone's and Judge Daniels ruled that CA had no authority and could not interrupt AZ law. (See attached court documents. THIS VIOLATES RULE 2.10 A. and RULE 1.3/ COMMENT 1 "(IT IS IMPROPER FOR A JUDGE TO USE OR ATTEMPT TO USE HIS OR HER POSITION TO GAIN PERSONAL ADVANTAGE OR DEFERTIAL TREATMENT OF ANY KIND)."

Once at home, the child goes on to say that while in the Chambers prior to lunch. Public defender Bransky came into the Chamber with Judge to visit with him. Bransky ask if he would like to stay here with Judge forever, the child said he did not respond. If indeed Bransky comes before Judge in court. The Judge will have to recuse herself due to the fact the case that Bransky has represented Ms. is still on going for the last three years. THIS VIOLATES CANNON RULE 2.11 A AND A1-ALSO 2.11 A6 (a) AND 2.11 COMMENT 7.

There are countless other violations she has committed from prescription drug use, to lying about finances, in concerning a life insurance policy left to her daughter and willed to her by her grandmother. THIS VIOLATES RULE 3.15. I SUGGEST THAT SHE BE REQUIRE TO REPORT AND DISCLOSE ALL OF HER FINACES FROM 2005 TO PRESENT.

Being the master of deceit Judge has successfully manipulated the court system into getting what she wants. With trying to put her daughter in jail it has affected her ability to do her job. It has also made it impossible for her to decide any case before her objectively.

Public confidence has been eroded by her improper conduct, as seen in YouTube killmeyer41 and flyers, mailed to over 2000 voters and business in the Coconino County. Media has once again taken note of Ms. personal and professional impropriety. (please see inclosed).
