To whom it may concern. I am writing this complaint against judge _____ of Maricopa county Family court located at 201 W. Jefferson Street Phoenix AZ 85003. On July 19 2010 I had a custody case. My attorney put in for me to be on the telephone because I currently reside in NJ and I could not afford to be there. I was out of work for awhile and could not afford air fare hotel and car rental. The Judge turned it down the day of court and didn't want to hear my testimony. My x girl friend _____ attorney Steven Suffrin didn't even object to it. My lawyer _____ then asked if they could take my x girl friends _____ testimony and take mine at a later date again he said know. My attorney also asked if we could postpone the hearing and he said know. SO mine side never got heard. Judge _____ took all my parental rights away from me. He gave her more that what she was asking for. I use to have two phone calls a day to my little girls and now I have 1 phone call. I have two little girls 2 and 1. My one year old is very sick with digestive issues. She is currently on a feeding tube and a 24 hour drip. My two year old is very upset when I call at night. She asks me if I can take her swimming or if I can pick her up at night. How do you explain to a two year old. That you can't and you only can call once a day. He justified it by saying I was emailing her too much. He is right I did email her a lot in the beginning but I was trying to talk to her and get her to do this peacefully for the kids. I never threaten her in anyway. There was never any domestic violence in our relationship. Judge _____ also turned me down in May, 2010 to have visitation with my girls. I request to fly out and pick them up and fly them back to NJ. So I could spend two weeks with them and he turned that down. I am very upset over this I have no relationship with my girls at this time.

On February 24 2010 we had our temp hearing. We were arguing jurisdiction because I want to take my children back to NJ where they were both born and there family is. We were only in Arizona for six months and three weeks. Judge _____ ordered that she had to accomplish something to prove to the court. That she could make it in Arizona. My x shows up in court on disability and know plan on how she can make it in Arizona on her own. He totally went back on his word and ignored what he said. He never

even made it a issue. Mrs. _____ resides in a house with an individual that has a violent past. I provided three restraining order to the court. He also threaten his father in law with a fire arm. It was over looked. On July 19, 2010 that individual contacted me and said If I relocated back to Arizona to be near my children. That he would blow my head off. That incident is documented at Harrison TWP police department located in Mullica Hill NJ 08062. I am very concerned that I will never have a relationship with my kids. I was never an absent father. I was in the delivery room when they were both born and in their life on a daily basis up to February 1, 2010. I was very close with my two little girls. I am a very good father. There is nothing more important to me then my kids. I have to be totally honest I never heard of a judge limited phone calls to talk to your children. I should be able to call my kids anytime I want. I'm a little confused by that

doesn't AZ want both parents in the kids life. If you can look into this matter I would greatly appreciate it.

I also would like to add I did not abounded my children. I was forced out of the home with a restraining order based on lies. The order was dismissed on February 24; I stayed in hotels for approximately 6 weeks. My vehicle blew a motor. I don't have any family or friends in Arizona. I had no choice but to leave the state. I really thought that my children would be returning home soon after court. All I'm requesting is that you look into this matter. I really don't feel I i receive a fair Hearing. I am not even sure if it is possible at this point to receive a fair hearing in Arizona.

If you need anything to assist you in your investigation please let me know. I have no problem sending you the emails that I wrote Mrs. We were together for 4 year and there were never any domestic violence in our relationship. She testified to that at our temp hearing February 24,. I really feel Judge violated my constitutional rights. He did not give me the opportunity to be heard or the opportunity to hear what was going on in the court room. The speaker kept going in and out. I just want my children back in my life again.
