ORDER

The complainant alleged a superior court commissioner improperly issued an injunction to prohibit harassment against her without sufficient evidence. The commission reviewed the allegations and found no evidence of ethical misconduct. Whether the commissioner should have issued the injunction is a legal question outside the jurisdiction of the commission. Therefore, the complaint is dismissed pursuant to Rules 16(a) and 23.

I became concerned when I realized the gun he was required to carry on the job did not belong

All they have to say is, "well, this is the address you were supposed to stay away from." How are you able to prove otherwise if it is a secret?

Dave Cottle asked me who knew I was working for Service Master. I told him, "no one." He asked me, then where did they get this information. I told him I had to put my work information on the forms at the police department.
