ORDER

The complainant alleged that a municipal court judge issued erroneous rulings by failing to grant her request for continuances. The commission reviewed the matter and found no evidence of ethical misconduct on the part of the judge. The judge acted within his authority in denying the continuances, and court rulings are not subject to review by the commission. Therefore, the complaint is dismissed pursuant to Rules 16(a) and 23.

Oct. 28, 2010

Edward [James] Paris and wife Alice Williams have been harassing me and stalking me for nearly a year. They pass by my home, on foot, at least six times a day carrying with them audio/video equipment. They have filmed me while I stood inside my front living room window. They audio taped me while I was praying on the phone with a client in my side back yard. They have taken

offense to my prayers and
have contacted the Prescott
Valley Police Department
on several occasions to make
false reports. [See attached
affidavit].

A surveillance camera
is placed on Paris' shop roof
which pans the entire front
yard of my home including my
front bedroom window. [See
affidavit attached].

Alice Williams twice brushed
up against me as I was
raking streetside the out
skirts of my four foot ditch
nearly forcing me off
my feet.

I took out an Injunction
Against Harassment against

Ivin Paris & Alice Williams.
They requested a hearing to
contest. A court date was
set on a day I needed to
be on the Reservation to
deal with a troubled teen.
[I'm a crisis Teen Advocate].

I wrote Judge
a letter begging him to let
the Injunction stand. ^{see copy of letter} I requested
^{enclosed} a continuance but was
told by the secretary, Lynn,
"that if I didn't show up the
injunction would be dropped"
and that in fact my request
for a continuance was denied.
[See copy of my letter enclosed].

Later Paris & Williams each
took out an Injunction Against
Harassment Against

me. A court date was set on a day I was called out of town. I again requested a continuance but was denied by secretary Lynn. As a result both Injunctions were set.

James & Alice saw me praying on my own property from their surveillance camera on July 26, 2010. They filed a complaint with the Police and on the 29th Day of July I was handcuffed and sent to Camp Verde Jail where I spent the night. I was released on the 30th Day of July 2010 on a \$3,000.00 bond. Two Felony charges were placed against me. Almost immediately all charges were dropped by County Deputy IV

charges dropped to misdemeanor.
All charges dropped - Never Filed.

Had Judge not deny
my request for continuance
none of this would have had to
happen.

I asked my attorney if we
could request a hearing to have
these Injunctions dropped
against me, as Tim and Alice
are on a mission to have me
re-arrested, and he said
"once Injunctions are set it's
the law they have to go full
one year term." I spoke
with secretary Lynn yesterday
and she said I could request a
hearing anytime to contest
the Injunctions." She said "some
people have them contested the day

before they are due to expire."

^{so which is it? very confusing}
I, the undersigned, am hereby
filing a formal complaint against
Judge for

ordering two Injunctions Against
Harassment against me based
on false reporting by Paris E. Williams.
and ~~most~~ especially for denying
me a continuance which led
to my false arrest and false
imprisonment.

As you will see from reading
the Affidavit all activity against
me was done while I was on
my own property. The audio/video
taping, etc.
