The complainant alleged that a superior court judge demonstrated bias by engaging in a conspiracy with his attorney and others to violate his right to a speedy trial. The commission reviewed the allegations along with the additional information submitted by the complainant and found insufficient evidence to justify further investigation. The issues raised involve legal matters outside the jurisdiction of the commission. The complaint is dismissed pursuant to Rules 16(a) and 23.

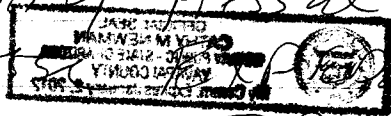
