Dear Commission on Judicial Conduct:

I am filing a Complaint against Judge _____ for judicial misconduct. Judge _____ should be investigated thoroughly because she refused to allow the majority of my evidence, classified and otherwise lightly esteemed the limited evidence she allowed, promised to allow me testimony to support my position then did not allow me time to give my testimony, refused to hear and evaluate fairly testimony from both sides of the issue before her, treated me disrespectfully for not having attorney representation and entered a clearly biased ruling. I have filled out your form and included a copy of the court transcript hearing of May 20, 2009, in which Judge _____ without giving me due process, rendered a completely biased opinion, entered an Order dismissing the Retraining Order I had in place against my estranged ex-husband, _____ for fear that he would kidnap our three minor children. Within two months after Judge _____ entered her Order dismissing the Restraining Order, _____ kidnapped our three minor children, and has willfully refused to return them to their Arizona home since August, 2009, despite the fact that two Orders of the Arizona Superior Court denied him custody, prior to Judge _____ Order and two Orders of the Arizona Superior Court and the Boston, MA Court have denied him custody of the children. This is a direct result of Judge _____ flippant response to my efforts to stop this horrendous thing from happening to my children and me. I spent countless hours and money fighting to right Judge _____ wrong in courts in three states since that time trying to make my estranged ex-husband return the children. I know what a hateful person he is and know that in the end law enforcement will have to forcibly take the children from him, not because he loves the children but because he seeks to injure me by holding them hostage.

Even when the children are forcible returned, that will not undo the damage to the children and my family. Therefore, I ask that you take the fullest judicial measures possible against Judge _____ for her biased order entered, which directly facilitated my estranged ex-husband to kidnap our three children. She has already ruined the lives of my children and must now be stopped from doing the same to others.
