ORDER

The complainant alleged that a superior court commissioner demonstrated bias during a dependency action by making inappropriate comments and returning her child to the father. After considering the allegations and listening to the three-hour audio-recording of the hearing, the commission found no evidence of ethical misconduct on the part of the judge. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.

I've been at 10 CPS meetings - Feb. 12 & 15, March 22, April 9 & 22, Aug. 18 & 26, Sept. 13, Oct. 14, Dec. 15 & Jan. 20, 2011. That's the last one, unless I get a new judge and a new case manager from C.P.S. Judge is giving temporary custody of Faith in 60 days. CPS is setting up a team for the team is coming to his home 3-4 times a week. To show him and tell him how to take care of his daughter. Judge & C.P.S. Victoria Hernandez isn't giving me a chance. They're

just ignoring me. Even though I'm here to get my daughter back. I live in Missouri, I came to Arizona ~~until~~ until the case close and take my daughter with me. Not happening. Feb. 24, 2011 is the last court date. That Judge will tell me who gets

Kirk Cree interviewed my daughter twice. 20 mins. and 15 mins. then on Oct. 6, 2010 Kirk closed the case. I feel that wasn't long enough especially when her dad molested her 2x's. My mom Susan was her foster mom. Her grandma. She took care of her for 6 months.

Before went to foster care on Aug. 31, 2010. told her grandma that her daddy hurt her. First was saying "my but hurt." Grandma said "why does your but hurt?"

Said "My daddy hurt me." Grandma said "How did your daddy hurt you?"

Said, "Thumb in my but." Her Grandma called CPS ~~hotline~~ hotline made a report. She even called Victoria Hernandez. She told her grandma that can't talk and that's just

here say, I don't believe you. Then she went to Mesa Police Dept. to make a report. They told her because is in C.P.S. care. Victoria Hernandez has to make the report. She called Victoria and told her what happened. Victoria said okay. On Dec. 15, 2010 at the court hearing. Her grandma was a witness. She told her story of what happened. Judge Victoria Hernandez, & Jeff Kolbe, they all say it's here say, they don't believe her. of what happened to
She's in DANGER

Nobody doesn't care. All they care about is the money. Judge even said "I can't wait until this case is over with so I can move on to the next one." He don't care about my daughter's life. Especially of what happened to her.

Attorney Anne Timmies wanted to get a court order for faith. So the investigators could do play therapy. Judge ignored Anne Timmies and told her it's not necessary to do that. They didn't interview

long enough. Especially when the child is 4 yrs. old and is frightened of her dad, and scared of him. I don't know how to take care of a child. I was Faith's sole provider. I was playing with her, dressing her, bathing her, feeding her and paying attention to her. I visit her 2x's a week. On Mondays and Thursdays at 9-11am. Everytime she asks me "When am I going home with you mommy?" I tell her, "Not right now you will later." I visit her on Dec. 23, 2010 - Thursday. I had alot of time by myself with her. I asked her "How does daddy treat you?" She told me, daddy hurt me. She started crying. Then she said "He put his thumb in my butt." She then put her thumb up in the air. She's crying out for help & so am I. Nobody cares about this. So, please help me before it's too late.
