ORDER

The complainant alleged that a superior court judge failed to enforce his own orders and did not schedule a hearing on his motion to compel but only set a hearing when the opposing party submitted a similar request. He further alleged the judge refused to hear his objections to three protective orders that a superior court commissioner improperly issued even though the opposing party did not meet statutory requirements. The commission reviewed the matter and found no evidence of ethical misconduct on the part of the judge or the commissioner. The issues raised involve legal rulings that are outside the jurisdiction of the commission and disagreement with a court decision is not sufficient evidence that a judge is biased. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.

Judge has twice issued P.O. without cause, she had previously been notified and presented evidence from Plaintiffs Attorney that the Protective Order would be dropped in exchange for 1- Dropping of Domestic Violence charges against, then for monetary considerations

Judge literally ran out of the court room when I asked for sanctions against plaintiffs Attorney for harassment after plaintiff said she filed the P.O. because Mr. Ruff told her to.

Judge has now issued another protective order against me for having a Federal Summons and Complaint sent to Plaintiffs address as required by the Federal court by a third party (enfile at Yuma Fed. Ct.) and after I asked for removal from a hearing on Judge disqualification. The Presiding Judge knows this.

Also Note That I went into and filed with the court to have the P.O. removed on 1-11-11, it was assigned to Judge who would not hear it.
