ORDER

The complainant alleged a superior court judge improperly terminated her parental rights.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of court rulings. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

I am concerned about this Judge because I am needing desperately support as much possible to do anything about this legal proceeding I went through the last two-three years ago with Child Protective Services forcing my parental rights to be terminated having me feel humiliated by the suicidal letters I written due to being distressful & traumatization of domestic violence I was consistantly lack of support with no family or friends that does not reside here in - and it was making me feel hopeless and very stressful being overwhelmed with the domestic violence occurring, Child Protective Services had lack of understanding towards me and right away took investigation to the court to humiliated me by the written letters to have me feel as if I am needing mental health service to proceed the law forward against me using legal documents to forcibly separate me & am children

to have my children adopted by another family, Child Protective Services was taking advantage of me as to a point because I seem quiet and forcing to understood to put whatever they want in the court system.

I understand clearly that it was not fair for me to write a suicidal letters to face this incident and go through all this legal proceeding to force the court system to ~~write~~ document false evidence because my abuser the current father of my children, he consistently threatens me to live in violence to force me to do things drastically that I will take the blame and keep me emotionally hurt, to have humiliated through the court system with separating me forcing my children away, humiliating me with mental health service as of abusing my self esteem when it is not necessary for any medications.

the lawyers that was suppose to support my facts did not help at all they just kept me in denial and humiliated me with Child Protective Services to force the court system to put false information on legal document, am literally being abused through the state system and my children forced into foster care.

it was "not" necessarily for any medications Child Protective Services is humiliating and lowering my self esteem putting me in denial towards psychiatrist those doctors' should be treated with malpractice.

the attorney's that was assigned to me they treated me as if am slow and retarded to go forward with separating me & my children, not letting me & my children bond & attach, taking advantage using the suicidal letters as revenge...

Another reason for my concern the state of Arizona violate alot of constitutional rights against me assuming that am mentally-ill because

of the lack of understanding of the suicidal letters I written to Child Protective Services. And CPS just took advantage and force my children to be with another family - It is "not" fair to forcibly take my children away from me and "not" let me have any relationship & bond and attachment towards my children assuming that I need mental health service because of how I written the letters to Child Protective Services...

When I had my second child I felt threaten at the hospital because the CPS case worker and nurse did "not" let me spend time with my newborn and "not" let me breastfed my child as I wish, it hurted to just de ~~attach~~ from me & my child at that moment...

This Judge had made an unruling ground forcing my children into foster care by the case workers of Child Protective Services taking advantage of lack of understanding

upon me and taking it forward to force the court system to establish ~~it on~~ false information on legal document on legal document by humiliating me by two different doctors' and also at the Team Decision Meeting Child Protective Services refuse me at all times to be taken advantage and forces separation upon me & my children.

The point to my situation that needs to be acknowledged is that I am determined to succeed and be consistent in many activities in my daily life as

Also as anyone can see I been seeking help by others to help me overturn my case myself by filing legal documents because that is where my mind is currently focus on, just to be stable and care for my children and myself as currently am being stabilize

the same ~~to~~ and not" to be treated all that way because of the circumstances I was going through and because I was consistently facing humiliation and discrimination on my self esteem through the court system and threatening upon doctors' telling me that I needed medication, when I was "not" having those symptoms....

It was "not" fair to treat me in the lack of understanding...

I drastically written the suicidal letters because I was in a unsafe situation due to lack of support of "not" having anyone to help me get away from my abuser the current father of my children, and I had to forcibly write letters to Child Protective Services assuming am needing mental health services having me humiliating towards Professional doctors, having lack of understanding towards me.

the current father of my children
; he denies and persuades
making situation to turn against me
and have me in denial for he can get
~~an~~ away with abusive behavior and
continue to take revenge of me by
threatening to get me to harm myself
having me feel as if am needing
mental health service,

this was also taken place at the
Team Decision Meeting.

This needs to be taken in consideration
because this is being acknowledged what
taken placed...

Another concern I have is when I
was in domestic violence situations the
lack of support from family & friends and

surrounding my life
with stress to force me into doing
drastic, it was "not" fair to have
Southwest Behavior making evaluations &
diagnoses when I was being psycholog
psychological abuse in domestic violence
because on a usually daily basis am

able to coordinate on my regular routine included with caring for children, am able to keep myself under control without being in domestic violence. it is "not" fair for ^{my self} being in domestic violence where am ^{my} forcedly to do things drastically and blame me as to assume am needing mental health services.

on a current basis being separated by the father of my children am able to coordinate on my daily routine and explore what ~~am~~ needing.
