**ORDER**

The complainant alleged a superior court judge was biased against him because of his ethnicity.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the complaint, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

DECREE; 2. REFUSED TO VACATE THAT RULING; 3. PUNISHED ME  
BY ORDERING ME TO PAY MY EX-WIFE \$1500 FOR ITEMS THAT  
WERE MY PROPERTY; 4. PUNISHED ME BY ORDERING ME TO PAY  
\$4,904.25 POST-DISSOLUTION ATTORNEY FEES TO MY EX-WIFE;  
5. PUNISHED ME BY GIVING MY EX-WIFE SOLE AUTHORITY  
TO SELL A JOINTLY-OWNED HOUSE WHICH I BUILT FOR US;  
6. REFUSED MY REQUEST AND MOTION FOR A CHANGE
