**ORDER**

The complainant alleged a municipal court judge set an improper amount of bail in a 2007 case.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of the court rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

I revere our System of Justice and believe in the Constitution, and the rule of law.

unreasonable intransigence destroyed our lives irretrievably. Harming <sup>my</sup> children is indefensible.

Upon my release from jail it took [redacted] exactly to hunt me down, and resume his harassment by attacking me at [redacted] on [redacted] in [redacted] Arizona. [redacted] attacked me three times,

at three different locations in [redacted] Commissioner [redacted] went far beyond the bounds of acceptable adjudication, or appropriate conduct. He acted capriciously like the mob at the [redacted] without regard to my presumption of innocence, and First Amendment protections under the Constitution. He disregarded the [redacted] to persecute me by [redacted] and [redacted] whose fraudulent court-ordered injunctions control, and regiment my life for racially-motivated hate-crimes. The [redacted] were the ones who collaborated with [redacted] and here, in a Court Room, history repeated itself through Commissioner [redacted] actions.
