ORDER

The complainant alleged a superior court judge showed favoritism toward the adverse party in his case based on her gender and the judge's personal religious beliefs and displayed an unprofessional temperament in the courtroom.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

 The photograph we provided at the hearing showed clearly that
 physical abuse was involved.

After [redacted] failed to take a hair follicle before [redacted] and never even took the hair follicle test period, and after she totally disregarded the Honorable [redacted] orders then the Honorable [redacted] requested me to PAY for [redacted] urinary test after the court hearing on [redacted] which the drug test came back dirty. I was already ORDERED to pay for the hair follicle test on [redacted] which I did, even though she never took the test. [redacted] should have been ordered to pay for all future drug testing. I feel it was absolutely ridiculous for me to financially pay for [redacted] blatant disregard of the court's orders in place for drug testing.
