ORDER

The complainant alleged a justice of the peace discriminated against her and failed to properly handle her case.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

Commission member Peter J. Eckerstrom did not participate in the consideration of this matter.

I have no contract with the state of Arizona for anything other than _____ therefore I don't feel as though I owe this state anything, and especially not to be their slave I don't ask you for anything nor do I want anything other than equality as a person, and surely not to follow a revised statutes that goes against THE CONSTITUTION OF THE UNITED STATES OF AMERICA.

I realize your office has nothing to do with the case and you cannot make any decisions relevant to matters other than whether or not any judicial misconduct has taken place which is why my concerns are being addressed with your office.
