ORDER

The complainant alleged a justice of the peace was biased against her, issued erroneous rulings, engaged in ex-parte communications, violated her due process rights and failed to let her examine a witness.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission approved sending the judge an advisory letter regarding Rules 1.2, 2.1 and 2.9(A). The judge was reminded to consider the appearance of impropriety and potential for error where he amends a party's petition based on the party's verbal assertions; to avoid extrajudicial activities that may result in disqualification; and not to engage in ex-parte communications. The complaint is dismissed pursuant to Rules 16(b) and 23(a).

Commission members Roger D. Barton, Peter J. Eckerstrom and Diane M. Johnsen did not participate in the consideration of this matter.
