ORDER

The complainant alleged a pro tem superior court judge improperly allowed an injunction against harassment action to proceed against him.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

By violating this Statute Judge _____ engaged in a conspiracy to Obstruct Justice, Intimidate a Witness, and Threatened a Witness with further Retaliation if they followed the law and reported Suspicious Behaviour concerning Child Sex Trafficking. Judge _____ ordered me to break the law under threat of more Retaliation.

The stipulations that negate immunity in the aforementioned statute have not been met. I was not acting with malice nor have I been charged or suspected of abusing the children in my good faith reports.
