The Complainant alleged a superior court judge improperly denied his request for records and acted without jurisdiction.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Delia R. Neal did not participate in the consideration of this matter.

After the dismissal of his first post-conviction relief proceeding, on Defendant again filed a Notice Requesting Post-Conviction Relief and a Petition for Post-Conviction Relief. The Court is also in receipt of Defendant's Request for the Court Record. To reiterate, because Defendant has not been convicted or sentenced, he is not entitled to seek post-conviction relief.

IT IS THEREFORE ORDERED dismissing Defendant's Notice Requesting Post-Conviction Relief and Petition for Post-Conviction Relief. This dismissal is without prejudice to Defendant's ability to seek relief in an appropriate type of proceeding.

IT IS FURTHER ORDERED denying Defendant's Request for the Court Record.
