**ORDER**

June 27, 2024

The Complainant alleged improper legal rulings and bias by a superior court judge hearing a civil case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Roger D. Barton, Louis Frank Dominguez, and Regina L. Nassen did not participate in the consideration of this matter.

I believe that \_\_\_\_\_ did not perform his duties as a judge in my case and that \_\_\_\_\_ was biased towards me, was impartial and not fair and had preferential treatment with the defendants and their attorneys and that it was improper., Abused his power and position as a judge in my case, was not compliant with the law or mandatory reporting statutes. I believe \_\_\_\_\_ to have participated in the abuse, harassment, discrimination, prejudice and stalking being done to me in \_\_\_\_\_ County/ \_\_\_\_\_ AZ and that \_\_\_\_\_ himself made inappropriate comments/jokes, slurs/racist comments and jokes against me during court proceedings in a negative and derogatory manner. . That \_\_\_\_\_ had a substantial personal, economic friend and family interest in the case and economic interest in the case against me and that he did not abide by A.R.S 38-501. I believe there were external influences on court duties and that the possibility of gifts and extra compensation for ruling against me was offered to \_\_\_\_\_ I believe \_\_\_\_\_ communicated with the defendants outside of the courtroom proceedings against me during the court proceedings and that I was discussed in a very negative manner. I believe information about my case was released to the public by the Judge and the Defendants during my case and used against me. I believe \_\_\_\_\_ provided information about my case to defendants and opposite counsel that was impermissible ex parte communication about my case. I believe that \_\_\_\_\_ communicated personal knowledge about my case with other members who worked for the court and outside of the court about the facts of my case which were pending before the court, during proceedings and after they were dismissed and that this helped to negatively effect the outcome of my case. I believe their was a conflict of interest in my case. I believe that \_\_\_\_\_ to have personally violated 97 percent of the ARS Statutes listed under the Rules and Constitution governing Judges and Judicial Staff.

The reasons that I feel misconduct and impartial improper illegal behavior by the Judge was conducted is because I made it known to the court during proceedings that my case was the highest profile case in \_\_\_\_\_ AZ/ \_\_\_\_\_ County, I had no assistance from local law enforcement and that they were participating in the abuse, that I had a National Human Trafficking Case Number, I had called the \_\_\_\_\_ times about these issues and spoken to them personally on the telephone, I had contacted \_\_\_\_\_ and the \_\_\_\_\_ I had quit my job at the \_\_\_\_\_ over these matters, I was relieved of Jury Duty Service in \_\_\_\_\_ AZ for \_\_\_\_\_ case over these same matters, my \_\_\_\_\_ Photos went Viral/Worldwide in \_\_\_\_\_ to present day then \_\_\_\_\_ my ex-girlfriend \_\_\_\_\_ and sister \_\_\_\_\_ and \_\_\_\_\_ boyfriend at the time

broadcasted me out unknowingly over [redacted] Live and used the footage in a [redacted] City Department investigation against me.

I asked to have to Venue of my case moved out of [redacted] County and transferred to [redacted] County to receive a Fair and Impartial Trial because I was so High Profile and Public and listed abuse such as my bike even being thrown down in front of [redacted] County Courthouse on either by someone who works for the court or someone in the community and it was so blatant that it was done right in front of the courthouse front entrance in front of security which I did take pictures of the aftermath and had to bring my bike then down to [redacted] bikes because my handlebars were twisted completely all the way around messing with my bike cables and subsequently then had to get the front part of my bike fixed and replaced. My personal property continued to get stolen, tampered with, harmed, destroyed. My laptop, cellphones and printer were tampered with somehow causing them to not work right and to slow down. I bought [redacted] cell phones in less than [redacted] months because of this problem, and [redacted] did contact the local area provider trying to figure out the problem but it was of no use at the time because the behaviors of others would not cease and desist. I was being stalked and harassed all over [redacted] AZ, called derogatory names. I had people breaking and entering into my house while I was not there and being in my opinion drugged in my sleep and then raped and physically assaulted where on one occasion I did go down to [redacted] on [redacted] and have a Forensic Medical Rape kit done by [redacted] team phone number [redacted] and their agency continued to check up on me for the next several months. I reported all this information to an Attorney I had to get for falsified Federal Charges on me to [redacted] who investigated the claims and checked with the [redacted] to find out these allegations were a scam phone number is [redacted] and I took a Polygraph Test with [redacted] of the [redacted] and spoke to [redacted] Private Investigator for all of [redacted] big cases like Death Row and stuff about my audio files I had recorded of these individuals. phone number is [redacted]

I told [redacted] and entered into court that I did fear for my safety and my life staying in [redacted] County and [redacted] did not seem to care about any of that.

I asked for [redacted] to be Recused as the Judge and to have a new Judge assigned with facts and explanation and audio proof submitted not only to the court but to all defendants and attorneys listed in the case as to why and [redacted] also refused to Recuse himself off of my court case and continued to preside and make a ruling in my case.

I read that for slander, libel and defamation of character and a few other listed injuries that I as a Plaintiff was entitled to a trial and that the burden of proof would then fall on me to prove my allegations. I believe [redacted] did not hold to the standard of judicial conduct and was improper dismissing my case without the right to a fair and impartial trial. .

I have confirmed from my mom [redacted] Phone Number [redacted] and [redacted] at [redacted] cook at [redacted] in [redacted] AZ [redacted] phone number [redacted] that indeed my [redacted] Photos did go Viral/Public/Worldwide and that both of them had seen my [redacted] Photos and [redacted] did tell me that she had seen my [redacted] Photos prior to my employment with [redacted] in [redacted] AZ.

I submitted audio on [redacted] and [redacted]. I was also being threatened with the safety and life of my son [redacted] by individuals that I did not know and had not ever met and this is also contained on the audio. The people harassing me [redacted], someone named [redacted] and someone calling themselves by the last name of [redacted] also stated that they personally knew [redacted] and had spoken to him personally and that it was a known fact the [redacted] would never make a ruling or decision in favor of me the Plaintiff because [redacted] himself hated me.

I would like to see [redacted] investigated for my entire court case and I would ask please if warranted that the maximum punishment punishable by law be imposed on [redacted]. I feel [redacted] is guilty of gross negligent unprofessional conduct, that he broke and violated the law, made improper judgements, did not follow the judicial code of conduct or the "Canons" that the Judicial Commission has in place for the standards of practice.

I have enclosed my entire court case and [redacted] Rulings and communication I have with opposing counsel. At what point with all of these facts does law enforcement, federal agencies become negligent with their actions and behaviors. At what point with all of these facts and cases would these agencies and law enforcement be made to admit and be held accountable for their actions. At what point are they finally deemed responsible of illegal activity and held accountable. It has been so bad that I walked [redacted] miles on blistered feet from [redacted] AZ to the Border of [redacted] taking me [redacted] days and I actually illegally crossed the [redacted] International Border and because of the abuse sustained by me from [redacted] AZ and [redacted] County I asked for Political Asylum and Refugee Status away from the [redacted] and to become a National Citizen of [redacted]. I was undocumented at the time so I could not be transported by [redacted] Federal Officials to [redacted] and I was returned to the [redacted] on the [redacted] Border briefly Detained and then sent back on United States of America Soil. I do not personally know of anyone else who has ever done this.

I thank you for your time reading my complaint and for taking my matters into serious consideration and investigating my claims, reading through my court case and listening to the audio that I am presenting.
