**ORDER**

June 27, 2024

The Complainant alleged in 2016, a superior court judge, now retired, improperly changed the custody conditions based upon false information that her lawyer did not challenge.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Roger D. Barton, Louis Frank Dominguez, and Regina L. Nassen did not participate in the consideration of this matter.

A new custody agreement came out

and I have a child who shared custody with  
Before this order, we had a different parenting agreement. The father went back to court with a lawyer to ask for more parenting time etc...

I had no choice but to respond. I eventually got a lawyer as well . My lawyer was .  
I was never in agreement to give more parenting time to the other parent and never agreed to other things now incorrectly, unfair and very mistakenly decided on our order.

After years of living with this order , nothing was never done to correct it  
After the decision was made by the judge I went back to my lawyer asking him and pointing him all the mistakes made.

He said he will file a petition to correct it , a week went by and he didn't , another week went by and he didn't file . I was calling and sending emails to his office and no response but the assistant said he was out of the office, then finally I got to talk to him and he said his grandmother passed.

Yet, time went by and he never did anything to help me. Weeks, months and I gave up.

Judge ruled without solid proof

My order says that I was in jail for weeks for assaulting my oldest son back when he was a teenager. ( False) There's proof out there that I was not. And for this reason she gave the father the final decision on medical if we disagree. Judge had never proof of me being in jail for weeks on her hands to ruled such a false statement and it's been stated in the order very clearly that I was.

The income was put on me as \_\_\_\_\_ a month  
I have never made that amount. (False) Some where, some how was mistakenly wrote.  
And because of it the father ended up paying only \_\_\_\_\_ dollars a month and because of the  
incompetence of my lawyer not ready to prove and provide what he needed it .  
Yet, that amount was wrong and she ruled as such .  
Father also lied and hide a lot of his income , that's where also my lawyer fell to prove.

She took part of my parenting time to give to the father . I never agreed to that but yes my lawyer  
told me pretty much I didn't have a choice on that part and my son being older we will end up with  
50/50

Also I was falsely accused of not taking my son to school, right from preschool, to first grade. (False)  
I did not take him to preschool, preschool is not required by law, it wasn't then . Kindergarten  
I was told by the school that it wasn't required for him to be there every day so I only took him few  
days a week . I'm sure is record of that at the school. First grade  
Impossible , I couldn't get away with that one , by law he has to now be in school so I did .  
My parenting time is and was for me to decide over my child and how I parent my child. There was  
no harm on not taking him on daily basis to kindergarten or preschool.  
As an example  
A lot of parents even decide to homeschool etc  
I have the right to decide

The father couldn't stand that fact .  
And lied several times to judges to make me look bad and take my son away .  
He succeeded at times  
As a great example with judge \_\_\_\_\_ a very incompetent judge who ruled without proper evidence  
and I had and have to live with to these day.  
You might ask why I waited all these years to complain.  
I do not handle very well going to court , I don't like it and I avoid it because I went through so much  
with this case that I didn't want to get stress anymore on trying to fix it.

Unfortunately also I hired a incompetent lawyer  
Who later on i find out he's been disciplined by the board and suspended for not doing/ finishing his  
work and that's exactly what he did to me .

At the end I had a bad judge and a bad lawyer  
And it has affected me because of that .  
Whoever wrote that order was very unprofessional  
Even couldn't write on the dates correctly for \_\_\_\_\_ parenting time

It is a very embarrassing court order if you read it

On the week vacation for what I understand doesn't make sense to me .

If the courts only knew what the father does , has done and still does  
He would not have my child . He has taken advantage of the situation of the judge given him the  
final decision on medical only to throw it on my face and remind me that he is in control  
He does whatever he wants , he does not follows the order, when it comes to as an example  
Letting me know about doctors appointments, address where he resides with my son , he only  
follows what is convenient for him.  
I can keep going but this complaint is about the judge .  
She sure made a big mistake.
