ORDER

July 23, 2024

The Complainant alleged a superior court judge has unfairly advantaged the father over her despite her evidence and has ruled too harshly against her in a family law matter.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Delia R. Neal did not participate in the consideration of this matter.

I was in a Family court case with the judge. He refused to listen to anything I said about Whom is the father of my kids. The better interest attorney also refused to listen to any of the alarming reports I had on . The judge did not think it was wise to put in any sort of classes with his violent history on top of him being in prison for years of the kids lives. They barely knew him. The judge and better interest attorney set a date to talk with my 2 kids and then canceled that meeting and never bothered to reschedule this meeting. I was immediately right from the beginning the bad guy they only wanted to hear about my history with past drug use and completely dismissed everything I had to say about He has a history of abuse and torturing me including kidnapping charges that were dropped because he convinced me to not show up to the court date. The kids didn't hardly know him. Him and his girlfriend continued to tell my kids terrible things about me . The kids were only and years old at the time. They didn't know what drugs were or that anything was wrong until and got involved in their lives. They've lied in court about my oldest daughter accusing her of sexual abuse that supposedly happened at house. He reported it to telling them it happened at my house. Both of my kids told me the same story that they were playing and she put markers in pants but he said she shoved markers in his ass. The judge ruled that their older sister can't be alone with the kids now. Also lied saying my mother has substance abuse issues. She's never touched drugs or been to jail for anything in her life. They just listened to what he said instead of investigating further. They set me up for a hair follicle which I passed then said I faked it. The judge believed him and then I had a UA come back with because I started taking my medication after not taking it for months. He just yelled at me for not telling him about the medication. So I released my medical records to them and allowed them to speak with my Dr. that wasn't good enough either. He told me I had to go to specific locations to do drug testing so I attempted to set this up at a facility on in and they couldn't find my case I went back and forth with them several times. So eventually I started going to . He told me there were no other places I could use. This was when I was going to court with no attorney. Now I have an attorney so last month my attorney asked about he told her I can go to any facility that does weekly or random drug testing. There's been several mistakes and misconduct done throughout my entire case and I'm not happy with this at all. The judge ruled that I wasn't able to see my kids until I completed months of clean drug testing and now I'm supposed to complete a year of weekly drug testing before I can have unsupervised visits with my 2 children. This ruling is extremely harsh with little to no evidence against me. I wonder how many other families have gone through this with this judge? I know the process and my rights and there has been a lot of wrong doing in this case.
