**ORDER**

July 23, 2024

The Complainant alleged improper legal rulings by an appellate court judge hearing a civil case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

I had high risk pregnancies and pregnancy complications are very real. Here in Arizona, ARS 13-3623 states that it is a felony for an individual to medically neglect a vulnerable adult. Since pregnancy complications are very real and since these pregnancy complications has the ability to incapacitate a pregnant person, I do believe Justice \_\_\_\_\_ has violated this state law. This means in his rulling on \_\_\_\_\_ to uphold the 1864 abortion ban not only caused him to violate ARS 13-3623 laws in regards to medical neglect of pregnant women here in Arizona by denying timely treatment of pregnancy complications if the required treatment is an abortion, he has also placed doctors in the state in committing the same felony. In matter of fact, he has made it to where any doctor who performs an abortion where it is medically necessary but not an immediate threat to the life of the mother facing a felony, the same doctor still faces a felony of medical neglect by failing to perform the medically necessary abortion.

Therefore, Justice \_\_\_\_\_ has placed all OBGYNs and ER doctors into a no win felony scenario. The only solution to this is for Justice \_\_\_\_\_ to be disciplined for intetnionally endangering the welfare of all women's health here in the State of Arizona and have him charged with the felony that he has committed. No one is safe in the State of Arizona while he is still a \_\_\_\_\_ Court Justice.
