ORDER

July 30, 2024

The Complainant alleged a superior court judge was biased in a family law matter based on allegations of mental illness against Complainant.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

I really need help. I have been bullied over and over since the day that my son was born about my mental health when it comes to [redacted] and his team at [redacted] in [redacted] removed my child secretly. Yes I knew I was being investigated but I was denied the right to know that my child was removed and for exactly what reason at the hospital during the time. The entire time the hospital made me believe that my son and I were OKAY. During that time I was living at [redacted] on [redacted] in [redacted] is a family service that offers housing for women and families. [redacted] who investigated my case, met me at [redacted] the day after I was discharged from the hospital and told me that he was removing my son from the hospital for neglect. I called the police and they told me that they will not interfere with his work. [redacted] also told me that I should not return to the hospital that day. I was unaware that I had a serious mental illness of [redacted] is a serious chronic mental illness that disables your speech and thinking process and [redacted] told the [redacted] Court that he needed my son to be removed because it was an emergency life and death situation. I was NEVER diagnosed with a chronic mental illness of [redacted] or [redacted] or any other illness that you can think of at the time of my discharge from the [redacted] where I gave birth. I have been dragging on the weight for the past [redacted] years with people thinking that I have a chronic mental illness because I have never had a chance to appear in the courtroom physically. I was restricted to Virtual court hearings from the beginning and I have never met my attorneys in person who compare my case and myself to women like [redacted]. Its a very sobbing story the story of [redacted] and I have a heart too but I don't need to be compared to this woman who kept rats in her apartment and lost her husband god rest his soul. The judge on my case Judge [redacted] is very prejudiced and I have felt that she is very inconsistent with my case. I don't even believe she knows what my case really is about because during our oral hearings all I hear is everyone bullying me and nothing seems like the truth of the matter. I have not heard a healthy conversation about my son and I or my husband who didn't even have a choice the country where I am originally from is at WAR and I had to FLEE. I ALSO HAD TO FLEE DOMESTIC VIOLENCE BY MY OWN FATHER AND BROTHER IN [redacted]. I have not been relieved of the [redacted] or [redacted] allegations from the beginning of the case even though NO DOCTOR HAS PROPERLY DIAGNOSED ME. I feel that I was also

misdiagnosed with _____ BECAUSE _____ TOLD THESE DOCTORS THAT I HAD BEEN DIAGNOSED PRIOR TO GOING. _____ has called the police on me and I have not been given a proper question and answer as to what occurred for court purposes. I email A LOT about what I have going on and none of that is expressed in the court room. My attorneys barely ask me anything I JUST DECIDED TO EMAIL ON MY OWN TO TELL MY STORY. THEY DONT ASK ME FOR ANYTHING. I JUST GIVE IT TO THEM. Sometimes I talk on the phone with my attorneys and sometimes we have virtual conference meetings between my attorneys and I. I just recently went to my husband who has been waiting for access to the United States Of America. I have applied for his visa and the process is taking longer than I anticipated. I only thought it would take a few months when I first started. Its been _____ years and _____ months since I applied for my husbands visa and he still can't enter the united states legally. He has never had a chance to meet his son because _____ and the Court removed him from my care stating that he would DIE in my care because they believed a LIE that I was diagnosed with _____ and that there are no reasonable alternatives but for my son to be out of home placement. Even though I have stated that I don't believe what I hear I have not been sent a single element of mail of the court orders. My attorneys do NOT provide me with court orders until I ask. SOMETIMES IT TAKES WEEKS ON WEEKS ON MONTHS AND NOW EVEN _____ YEARS TO GET THE COURT ORDERS OR THE ENTERIES IN COURT SO I CAN FOLLOW ALONG. I HAVE NOT BEEN ABLE TO FOLLLOW ALONG THIS ENTIRE TIME. EVERYTHING IS GIVEN TO ME MONTHS AFTER THE FACT OR EVEN _____ YEARS AFTER THE FACT AFTER I ASKED OVER AND OVER AND OVER. I have been without my baby _____ for _____ years. They Juvenile system has had him since the day I gave birth. And not because I am an addict to any drugs or alcohol not because I had to go sit in a jail cell or in a hospital bed but because of a lie that has followed me for _____ long years. I have lost services that I have achieved on my own that benefited us as a family due to _____ involvement just because I was honest with the hospital about why I was being sheltered by _____ which is domestic violence without getting into much detail with you. I hate talking about it now because I got in so much TROUBLE for NOTHING that I did. I feel punished for nothing that I have done by my own hands. I want to add that a few staff members who were on my case at the hospital were relieved of their duties with the company and I feel its because I complained when I did at that time and that was the consequence. During my first initial trial where Judge _____ was there my story was never painted to the correct happenings during the time of birth or even prior to birth everything was painted in the oral trial to the outcome of dcs invovlement and it has made things very confusing for me. The initial attorney general and my initial attorney have both been dismissed from my case. I have had to deal with the consequences since they have been removed and I feel that none of the services that are being provided to me are what I need to reunify with my son. EVEN THE SERVICES THAT I ACHIEVED ON MY OWN HAVE BEEN MANIPULATED INTO THE COURT BELIEVE THAT I HAVE A MENTAL ILLNESS BECAUSE I REFUSED TO GO TO ANOTHER SHELTER EVEN THOUGH INVESTIGATOR KNEW THAT I HAD OTHER PLANS HE FAILED TO REPORT THAT TO THE COURT HE MANIPULATED THE ENTIRE COURT TO BELIEVE THAT I HAVE THIS MENTAL ILLESS OF _____ HE MANIPULATED OTHER SOCIAL WORERS TO BELIEVE THAT I WAS DIAGNOSED WITH _____ AND HE MANIPULATED OUT OF STATE PSYCHIATRISTS TO

BELIEVE THAT A DIFFERENT STATE DIAGNOSED ME WITH A SERVE MENTAL ILLNESS OF . I have been with my husband in and virtually visit my son every week sometimes for an hour a week sometimes two hours a week and sometimes makes an excuse where I don't see my son for a week or two weeks. The system is destroying me as a human as woman I I can only take so much of so many people telling me that I'm wrong or manipulating the situation and restricting my son from me. I haven't even committed a crime or gone to jail and I haven't even been diagnosed with a life or death mental illness. And I have NEVER been ROUGH with my own child. I had to go see my husband because NO ONE IS TELLING THE TRUTH. I HAVE TOLD MY ATTORNEYS OF WHAT I BELIEVE HAPPENED TO ME AND THAT IS MY OWN REPORTING TO THE HOTLINE ON ANOTHER MOM WHOS CHILD ATTACKED ME WHILE I WAS ALMOST FULL TERM PREGNANCY. I have no social support, no one to hold me when I cry, no one to help me when I feel like it's too much to handle. Nights are really hard and sleeping pills just SCARE me. I heard too many stories of people dying from the outcome of medication. I like oils. I like healthier methods where there are barly any risks like pooping blood because you need help sleeping or worse dying because the fact that you needed help sleeping. I like understanding whats happening to my body instead these pills are understood by experts and I feel like the symtoms are too much for me. Young aged women having strokes and heart attacks and sever illnesses like cancer due to medications I would rather avoid that happening to me. I want my son and I don't feel like my rights should be terminated because Judge fails to realize that I'm a good mom and a good woman to a good man for me. Judge fails to realize that she's been destroying my life for me because she doesn't give me a chance to defend myself for myself and I don't think she READS any of the service reports that has referred me to. The Services from the that Judge wanted me to complete actually supported that I was a GREAT MOM and the services from the mental health evaluations actually supported that I had OTHER issues not CHRONIC MENTAL ILLNESSES THAT WOULD CAUSE MY CHILD DEATH. Judge always wanted me to complete these servcies yet she fails to provide me with the orders and I feel like Im doing everything voluntarily not as a consequece its really a differnt feeling and Im taking everything in a different way than if things would be done normally. NO MATTER WHAT ANY OF THEM SAY INCLUDING JUDGE THE DOCUMENTS I HAVE NOT RECIEVED PROPERLY AND THEY ARE NOT SIGNED FOR LEGAL PURPOSES NOTHING HAS BEEN VOLUNTARILY DONE BY ME I HAVE BEEN DOING EVERYTHING BY CONSEQUENCE I HAVE FELT BULLIED THIS ENTIRE TIME ITS CHANGING ME MAKING ME CRY SO MUCH MORE WHEN I SHOULD BE HAPPIER OR MAKING ME FEEL FRUSTRATED WHEN I SHOULD FEEL RELIEVED THE MENTAL HEALTH ALLEGATIONS ARE BEING TAKEN TO FAR I AM NOT DISABLED I AM A BULLIE WOMAN. I HAVE EVALUATIONS THAT I HAVE BEEN MADE TO COMPLETE AND I HAVE BEEN MADE TO RELEASE THESE MEDICAL RECORDS TO EVERYONE AND THAT I FEEL HAS GIVEN ME MY OWN PERSONAL VULNERABLE ISSUES. I HAVE BEEN BULLIED SO MUCH I THOUGHT I WAS HELPING MYSELF TO VOLUNTARILY ADMIT MYSELF INTO TREATMENT CENTERS THAT I KNOW I DO NOT NEED. I FEEL EXPLOITED I FEEL LIKE IM SPENDING MONEY ON HEALTH THAT I DO NOT NEED AND I FEEL THAT I ONLY NEED RELIEF FROM COURT

AND ATTORNEY AND SOCIAL WORKERS BECAUSE ALL THEY HAVE BEEN DOING IS KEEPING ME AWAY FROM MY BABY EVERY SINGLE REFERENCE TO A SERVICES HAS BEEN USED TO LIMIT THE TIME I HAVE WITH MY BABY BOY EVEN THOUGH THEY PROMISED TO REUNIFY US.. IM REALLY SCARED THAT I AM NEVER GETTING MY CHILD BACK ALL BECAUSE OF JUDGE . I have had no witnesses in court to my defense when it came down to what really happened. As I stated, a few medical professionals no longer work at the hospital and I feel that it's due to the case going on. was involved the day after I gave birth to my son because I was ALONE not because I have a chronic mental illness of but it has NEVER BEEN SAID. I ALSO FEEL THAT USED MY OWN HOTLINE REPORT OF ANOTHER CHILD AND HIS MOTHER AGAINST ME. Judge keeps referring my son stay out of home placement because I have a serious mental illness of which is NOT true. She is also referring my son out of home placement because I keep bickering with case managers about FOOD and TREATS which suspended my visitation from my son. FOOD THAT MY SON ISN'T EVEN ALLERGIC TO OR WOULD CAUSE HIM DEATH FOOD THAT ANY GIVEN PERSON WOULD GIVE A BABY THAT THEY WANT TO SPOIL AND TAKE SILLY PICTURES WITH. Judge also has my son out of home placement because and I haven't completed the parenting classes. I don't know called the police on me one day when I was told that I could bring teething medication for my son and vapor rub and then after spending that money being told that they would not take it to the out of home placement and restricting my son from using the products altogether. called the police because I was screaming and the old lady that was supervising me felt scared of me but she was the one who kept escalating the situation she was having a conversation with me she lied to everyone about what happened I never even heard the court talk about vapor rub or teething medication which was about that police report I think she told the court that I gave my son another cookie and that's why she called the police I also think she told the police that it's the craziest stories that I hear and Judge taking it serious and not giving me a chance to document what happened for reasons the court should need I don't know really know the law but I don't feel that everything is being document not even the bruises that my son has or the scratches my son had on his face.. That has all done something to me it has really affected me that did something to me..... even though I asked this certain supervisor to check with the out of home placement about teething medication and vapor rub BEFORE I even purchased the items which this supervisor did give me the okay go ahead and do it and I double checked to make sure it was okay before the visit ended I even told her Im bringin it next visit this supervisor decided to instigate an argument with me the following week and make me feel like I wasn't a mother to my baby by calling the police on me she really did something so bad to me. Judge allows all this to happen to me and she also doesn't care to know the truth; by asking the right QUESTIONS. No one cares. She has limited the conversations during the hearings to the attorney general, my son's attorney and case managers. My attorneys don't even motion the court for ANYTHING unless they HAVE TO which is toxic for me because I wanted to be able to give my side and say SO MUCH and it angers me I think that's what is happening to me they want me to be angry and confused. I have NEVER had the proper chance for the court records. case managers at EVERY SINGLE HEARING manipulate the court into believing that I am a terrible person and

mother who is refusing to communicate with them even though I SEND SO MANY EMAILS they want to talk about missed phone meetings that they scheduled with me. Im tired of yelling at them thats why I missed the phone call I don't want to yell they all did that to me... they did that to me they make me yell and cry. I wanted to avoid those people. The case managers write the craziest things about me and its supposed to be taken as GOOD WORK. They are causing me to change by bullying me. Any given person like myself can only take so much of being bullied and listening to demands before the person feels they exhausted everything they have in them and they choose not to be a nice woman anymore to that type of environment. Judge allows the court to continue with terminating my rights she has it scheduled for next court hearing with bits and pieces of the findings I need some help. I need to feel relieved I need my family back. This case is a mess because of Judge . And IS A HUGE LIAR.- I want my son to be in with my husband and I I do not want to be without him anymore I feel too vulnerable now everything I know to do is destroyed. I need a task force. I really have my child around family members who hate my existence and it's a really scary thought. You're my only hope for justice.
