ORDER

The Complainant alleged a superior court judge was biased in her ruling in a protective order case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Christopher P. Staring did not participate in the consideration of this matter.

Copies of this order were distributed to all appropriate persons on November 22, 2024.

I believe that Judge _____ has violated the spirit of the first two paragraphs of the Preamble to the Arizona Code of Judicial Conduct by not enhancing confidence in the legal system and by not conducting herself in a manner that ensures the greatest possible public confidence in her impartiality and her competence.

I believe that Judge _____ has violated Rule 1.1 of the Arizona Code of Judicial Conduct by not complying with the Code.

I believe that Judge _____ has violated Rule 1.2 of the Arizona Code of Judicial Conduct by failing to act in a manner that promotes public confidence in the impartiality of the judiciary.

I believe that Judge _____ has violated Rule 2.2 of the Arizona Code of Judicial Conduct by failing to perform her duty fairly and impartially.

I believe that Judge _____ has violated Rule 2.3 of the Arizona Code of Judicial Conduct by:

1. Acting with bias or prejudice.
2. Manifesting in her words bias or prejudice
3. By engaging in bias, prejudice or harassment based upon the fact that I am a man and/or that my skin is white and/or that I am _____
