ORDER

The Complainant alleged a superior court judge had inappropriate demeanor, violated her rights, and was biased by meeting with individuals outside of court in a juvenile case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar, Delia R. Neal, and Joseph C. Kreamer did not participate in the consideration of this matter.

In _____ of _____ my family began court proceedings within Judge _____ court and with _____.

Following the initial mediation, while waiting for court my _____ year old son began to panic and to tell his father and myself that he and his sister had been tricked into a vehicle under false pretenses by an unknown _____ agent.

This agent took their phones and took them to an unknown location and were left for close to _____ weeks uncertain of what was happening and where they even were.

Judge _____ entered the courtroom and yelled " _____ "!

This marks the first time my son was prevented from reporting _____ abuse.

Judge _____ then allowed perjured testimony in her court by _____ agents that had been dismissed within a higher court and memorialized more than _____ days prior.

These _____ agents also lied about the father's being listed on my children's birth certificates.

Neither Father is listed on either birth certificate.

This testimony was then used by _____ to substantiate their own perjured allegations.

Judge Court transcripts from just over days prior memorializes the dismissed information these agents used.

Three court hearings prior to the last, I informed Judge that I would not engage nor comply with the agency nor any agents.

Judge did not hold me in contempt within that hearing nor the one following.

It behooves me to mention that within the last hearing I refreshed Judge of the hearing prior, where within I gave her notification of my intent to in no manner engage nor comply with or their agents.

One AAG has been dismissed due to misconduct as well as the first agent for misconduct, the Special Investigator for verbal abuse and misconduct. As well as for misconduct and I have opened a criminal case within County against her as well. The last agent present in court perjured herself to the AAG

is former Criminal Justice and Former and will testify to this fact.

Moving forward. The prior week for a hearing that was scheduled for I officially gave in person notification to the Court Clerk of the intent to represent myself pro se, I also provided personal identification verification.

The following day my former Attorney officially memorialized with the Court Clerk that she would be removing herself from the case and entered myself in Pro se.

On I entered open standing objections in reference to all that I have aforementioned. As these objections had yet to be officially entered onto transcript.

I also entered an oral motion to modify the "Reunification Plan". This was in effort to be granted relief from all the acquired permissible requests from to the courts that were solely based upon perjured allegations substantiated by perjured allegations.

The same perjured allegations that were later dropped within the allegation mediation.

However, she cut me off and forbade me from making any further comments even with a request in respect to having one more moment.

This all begins to enter into the court transcript's timeline where I had begun to reference her judicial measures of misconduct.

She denied my request and then in her mania panicked. Then instead of offering relief, she strengthened the reunification plan grossly. In the past three hearings Judge did not correct behaviors performed by agents in court nor did she during the last hearing either.

In transparency and with the purpose of identifying the obvious bias openly practiced within Judge _____ courts; I admit that within the last hearing I mocked the agents. Turning and huddling to the right. Not facing the Judge's bench, and talking during processions. They are even over "utilizing" their cell phones and based on what I can see that they're doing, it is absolutely unnecessary. Not to mention it states on the courtroom doors to turn off all cell phones before entering.

As for this particular court involving children's anonymity it is completely understood.

I also giggled during _____ poor preparation of his initial statement.

As you see within _____ initial statement he degraded me with heinous unsubstantiated accusations indeed, but he also did so with my children present.
