The Complainant alleged a justice of the peace was biased in her rulings in protective order proceedings.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Barbara Brown did not participate in the consideration of this matter.



Hello, My name is [redacted] I spoke to you earlier in regards to filing a complaint. I filed a order an of protection on [redacted] and defendant wasn't served until [redacted]. There was a hearing [redacted] at the justice court on the said order of protection in which [redacted] wasn't the original judge who granted my order but she presided over that hearing on [redacted]. [redacted] had a very bad attitude the first time, she gave me as the plaintiff one minute to plead my case in which that wasn't enough time, [redacted] wouldn't allow me to show her MY evidence that would justify order of protection, she treated the defendant as if she already made her mind up in which [redacted] did without allowing me to show evidence and I walked out due to the injustice I had received. The next day [redacted] I had another incident with the defendant and filed another order of protection and added the injustice of the [redacted] court appearance, I spoke to another judge not [redacted] the same day [redacted] and the judge that presided set a trial so I could plead my case and show my evidence for Order of protection scheduled for today [redacted]. I asked the judge I spoke to [redacted] if I could get another judge not the last one [redacted], because it was an unfair hearing and the judge told me it would be somebody else that would preside over my new order of protection case and that would be the time I could show evidence. Well today [redacted] I walked into court, and waited to see what judge I was getting and was HEAVILY disappointed that it was the SAME judge that I had in my last order of protection complaint that the last judge told me I wasn't getting. I was immediately irritated, had the same attitude as last time, wouldn't allow me to show my evidence on my phone YET again that were the police reports etc to prove my case. [redacted] allowed the defendant to speak in the background as I'm trying to prove my case even though this so called judge won't see any of my evidence. [redacted] already had her mind made up even before I could speak, she had a very condi sending tone, very rude, she was very respectful to the defendant who's known for filing false police reports and took the defendants word on text messages that I didn't know neither did the "judge" if they were fake texts or not and yet this same judge wouldn't see my evidence with police reports attached that would prove Stalking and harassment I've had to deal with for years involving the defendant. [redacted] spoke of previous orders of protection Ive put on defendant in which were all dismissed because I didn't show up for hearings due to snow back then. This judge was very disrespectful, allowed the defendant to lie under oath, of you look at transcripts of this court hearing today you'll hear the frustration and the non chanlant tone and don't care attitude from a "judge" who picked a side and dismissed my case when I had the evidence, that's the reason of today's court appearance and I didn't get that. It caused me once again to raise my voice to the point security had to step in, I'm not filing orders of protection for no reason, I have the evidence to prove harassment etc. However this incompetent judge has now put me and my kids in more danger with the defendant because [redacted] didn't wanna do her job. Ill also be filing a complaint with the Commission on Judicial Conduct for judicial misconduct. Thank you
