ORDER

The Complainant alleged a superior court judge did not provide an interpreter and made improper rulings.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Even for something as fundamental as providing a translator—my legal right—they promised assistance for the court hearing, yet no proper opportunity was given for me to speak. Despite all my efforts, I must emphasize again: this case, from the beginning to the end, is based on lies.

Is it fair that because I cannot afford a lawyer, I am treated unfairly?

"All's fair in love and war," but I still believe in justice.

Hi. Is it possible that, after months of me explaining how my ex-wife has caused me the worst harm and pain imaginable, with all the evidence to prove it, no one has paid any attention to me? Is it because my English is not strong? Is it because I didn't have a lawyer? Does not having a lawyer make someone guilty?

Until _____, I had no knowledge of what was happening. I even asked my ex-wife about these matters because I didn't understand them. I sent messages that morning asking for help, explaining that this case was false.

Did you allow me to speak on that day? Did you hear me when I said I didn't understand what she was saying? Did I not repeatedly say that I don't understand English well?

I also said multiple times that my signature had been forged— did anyone care? All the pain and suffering I've endured doesn't seem to matter because I didn't have a lawyer? Well done, justice!

I told

you my ex-wife forced me to say I'd leave the house because she threatened me, and I have proof of that— did anyone care? For weeks, I haven't seen my son— has anyone cared? My ex-wife sold all my personal belongings— did anyone care? And so many other injustices.

I even sent screenshots of my lawyer's findings— did anyone notice? I had no idea about this forged signature until months ago, when my lawyer informed me. My ex-wife told me she loved me for _____ years, all the while forging my signature, and not once did she tell me the truth.

There's so much more— pain and suffering beyond words.

To the Honorable Judge,

I swear to God that as long as I live, I will fight against the lies and injustice that have been imposed upon me. My wife wrongfully took my son, and the signature she forged was entirely false and fake. Even if you sentence me to years in prison, I will continue to pursue this case from inside prison and prove that all these accusations and forgeries are baseless. My son was taken from me under false pretenses, and my rights have been violated.

I have nothing left to lose—my job, my car, and my son, everything has been taken from me through lies, and she laughed in the process.

Respectfully and in pursuit of justice,
I did not have access to a translator who could be approved by the court. I am sending these emails to you, so if possible, a translator could interpret them. Many things will become clear, and you will understand how much my ex-wife has lied and tortured me."
