**ORDER**

May 23, 2025

The Complainant alleged a superior court judge had a conflict of interest because of her spouse's employment in a company in which some of their employees were employed by another company related to a lawsuit.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Joseph C. Kreamer did not participate in the consideration of this matter.

In \_\_\_\_\_ filed a lawsuit against \_\_\_\_\_ for the theft of wages from employees, the case was removed to \_\_\_\_\_ Court for class action certification the class was not certified due to the broad scope in trying to include employee in another state \_\_\_\_\_ where \_\_\_\_\_ had additional call centers. The class action attorneys withdrew, the additional issue was a wrongful termination. \_\_\_\_\_ took over the case files pro per and proceeded remanding the case back to AZ State \_\_\_\_\_ Court.

\_\_\_\_\_ found an email in the case file in which the \_\_\_\_\_ executives admitted the commissions being withheld, were indeed guaranteed. In Arizona an employer cannot require that employees turn over commissions as it is criminalized via A.R.S. § 23-202. The \_\_\_\_\_ management back dated termination documents and fired him for stealing polices, however it was on a date that pre dated his hire date as the evidence shows. They then changed the word commissions on the commission calculations to "eligible bonus". The Court upheld for cause even though the reason was made up and on a date pre dating his actual employment start date.

\_\_\_\_\_ tried to request a hearing before the Court, to show evidence and admissions of the criminal activity, but \_\_\_\_\_ denied the request and refuse to bring the case to final disposition. \_\_\_\_\_ kept attempting to request a hearing and was deemed a vexatious litigant and \_\_\_\_\_ issued 3 final Judgements against \_\_\_\_\_ and then had his wages garnished.

\_\_\_\_\_ worked for \_\_\_\_\_ years and labored off the debts rather than filing bankruptcy and paid off all judgments, because he had won a similar case in \_\_\_\_\_ which set the precedent for this court circuit. \_\_\_\_\_ ( \_\_\_\_\_ ), the case determined that once a commission is calculated there is a triable issue of fact. \_\_\_\_\_ had the document showing that the commissions were calculated before they were withheld.

\_\_\_\_\_ found a document on the AZ Secretary of State website in which Judge \_\_\_\_\_ discloses that she financially benefits from her husbands \_\_\_\_\_ employment. attached pdf.

In researching the inception of \_\_\_\_\_ it was at a date when \_\_\_\_\_ was deemed a vexatious litigant and forced by the \_\_\_\_\_ court into State garnishment, while her and her husband were recieving a windfall of royalties by producing the \_\_\_\_\_ golf clubs at the same time.
